OFFICE MEMORANDUM

Aizawl, the 31st July, 1996.

**Subject:** Participations by Govt. servants in various organisations.

It has come to the notice of the Govt. that some Govt. servants have joined or enrolled themselves in various organisations without making prior intimation/without obtaining permission of the Government.

A Govt. servant is not required to obtain permission to enroll himself as a member of well-known social organisations like YMA, YLA, MHP, ZUP, recognised service associations and such sports associations which are duly affiliated to Mizoram State Sports Council. An exemption is also made from obtaining permission/giving intimation in respect of a Govt. servant in the event of his/her being elected an office bearer of the aforesaid associations. But he should invariably give information/intimation to the appropriate authority when he/she is elected as an office bearer of the above organisations, recognised service associations, etc. A Govt. servant who wishes to join or take part in the activities of any other association or organisation should invariably obtain prior intimation/permission of the Govt. In the event of being elected as an office bearer of such organisations, he/she should obtain ex-post-facto permission of the competent authority immediately after he/she is elected.

The prescribed authorities to grant permission for the above purposes are as follows :-

- (1) THE VIGILANCE DEPTT.: In case of Group 'A' officers whose starting pay is Rs.3,000/- p.m. and above. The application should be submitted to Vigilance Department through their respective Administrative Department or cadre controlling Deptt.
- (2) THE ADMINISTRATIVE DEPTT.: In case of Group 'A' & 'B' officers whose starting pay is less than Rs.3,000/- p.m.

(3) THE HEAD OF DEPTT. : In case of Group 'B' & 'C' and 'D' employees.

All Secretaries/Head of Deptts./Heads of Offices are requested to circulate this Office Memorandum to all the concerned Department Subordinate office/Circle offices for strict compliance. Any violation of the above Rules will render the Govt. servant liable for disciplinary action.

This supersedes the Office Memorandum issued earlier by this Department.
