Terms of Reference:

1. The Chairperson and the Members of the Search Committee shall hold office for a period of 2(two) years from the date of appointment and shall be eligible for re-appointment. The Selection Committee may, where it is of the view that the continuance of a member of the Search committee is not expedient in the public interest, after giving him an opportunity of being heard, remove such member before the expiry of his term as per Rule 3 of the Mizoram Lokayukta Rules, 2016.
2. A member of the Search Committee shall be entitled to a sitting fee of Rs.1500/- for each day for attending the meeting of the Search Committee as per sub-rule (1) of Rule 4 of the Mizoram Lokayukta Rules, 2016.
3. A member of the Search Committee shall be entitled to a Travelling Allowance and daily allowance as are admissible to a Secretary to the Govt. of Mizoram for attending the meeting of the Search Committee as per sub-rule (2) of Rule 4 of the Mizoram Lokayukta Rules, 2016.

4. The Search Committee shall prepare a panel of persons of not less than 3 (three) and not more than 5 (five) each for the Chairperson and Member (other than a Judicial Member) to be considered by the Selection Committee for appointment of the Lokayukta.
5. The Search Committee may, for the purpose of short listing persons, devise its own procedure or lay down guidelines for evaluating persons for the purpose of empanelment as per sub-rule (2) of Rule 5 of the Mizoram Lokayukta Rules, 2016.
6. The Search Committee shall submit its recommendation to the Chief Minister & Chairman, Selection Committee by 26th of August, 2023.
