**Subject: Extension of timeline for submission of Annual Property Returns for the year ending 2018.**

Online submission of Annual Property Returns has been made mandatory for all Group 'A' and 'B' Gazetted officers @ [www.propertyreturns.mizoram.gov.in](http://www.propertyreturns.mizoram.gov.in) with effect from 1<sup>st</sup> January, 2019 vide this Department's O.M. of even no. dt. 26.10.2018. Although compliance is satisfactory till date, it is observed that some officers are not able to submit their Annual Property Returns online by themselves and need technical assistance from the officers and staff of Vigilance Department. **Therefore, the timeline for online submission of Annual Property Returns for Group 'A' and 'B' Gazetted officers for the year ending 2018 is hereby extended upto 28<sup>th</sup> February, 2019.** It may be borne in mind that the extension of timeline does not include Group 'B' Non- Gazetted officers who are to submit their Annual Property Returns manually to their concerned Prescribed Authority within 31.01.2019.

It is reiterated that late submission of Annual Property Returns results in denial of Vigilance Clearance.

All Administrative Heads/Heads of Departments/Service Controlling Authorities are requested to immediately inform all Group 'A' and 'B' Gazetted officers under their control to submit their Annual Immovable Property Returns within the extended timeline positively. An acknowledgement may be obtained from all the officers and kept ready for future reference.
