**NOTIFICATION**

In the interest of public service, the Governor of Mizoram is pleased to constitute a two-member Inquiry Commission consisting of the following members to inquire into the sponsorship of students by Mizoram Youth Commission (MYC) and Mizoram Building and Other Construction Workers Welfare Board (MBOCWWB) to Nalanda Institute of Advance Studies (NIAS), Kolkata during September, 2014 and functions of the Welfare Board and its related issues, namely.

1. Pu Benjamina, IDAS, Commissioner and Secretary, H&TE, LE&IT
2. Pu Neeraj Thakur, IPS, PHQ, Aizawl

The terms of reference of the team shall be as follows:-

1. To enquire into the allegation of involvement of Pu Lalrinmawia Ralte, MLA and Pu T. Sangkunga, MLA in the selection for sponsorship 32 students of NIAS, Kolkata without prior verified of the credential Institute.
2. To enquire into the allegation of mis - utilization of Mizoram Building and Other Construction Workers Welfare Board (MBOCWWB) Fund for unauthorized Skill Development Training.
3. To enquire into the allegation of issue of unauthorized disbursement of loan from the Welfare Board Fund.
4. To enquire into the allegation of signing of Memorandum of Understanding between Mizoram Youth Commission, Welfare Board and Nalanda Institute of Advance Studies while the MOU has not been approved or vetted by the Government of Mizoram.
5. To enquire into the unauthorized appointment of officers and excess staff of the Welfare Board.

The Inquiry Commission shall submit their Report on or before 20<sup>th</sup> May, 2017.
