CIRCULAR

**Subject: Submission of Annual Statement of Immovable Property Return.**

As stipulated under Rules 18 of CCS (Conduct) Rules, 1964, Annual Statement of Immovable Property Return as on 31<sup>st</sup> December of the preceding year is to be submitted by 31<sup>st</sup> January every year. Attention of all Group 'A' and 'B' Government servants is hereby invited to this Department's Office Memorandum vide No. C. 29018/1/2017 – VIG dt. 07.10.2019(which can be downloaded from [www.vigilance.mizoram.gov.in](http://www.vigilance.mizoram.gov.in)) wherein it was clearly mentioned that non-submission of Annual Statement of Immovable Property Return will result in withholding of salary. As such, the salary of such defaulters will be withheld from the month of February, 2021 till such time their Immovable Property Return is submitted to the satisfaction of Vigilance Department. The return is to be filed online @ [www.propertyreturns.mizoram.gov.in](http://www.propertyreturns.mizoram.gov.in). It may be noted that Property Returns submitted by Group 'A' and 'B' officials will be examined and considered in the Department. The status of their Property Returns which will first appear as 'Submitted' will later appear as 'In process' or 'Rejected' or 'Acknowledged', as the case may be.

Therefore, it is hereby clarified that the process of withholding of salary will become a continuous process for the whole year in respect of officials who do not submit their Annual Immovable Property Returns and whose Returns are rejected for want of additional documents until and unless the desired documents are furnished to the satisfaction of Vigilance Department.

Nodal Officers of all Departments and Cadre Controlling Authorities are once again informed to furnish list of defaulters before 15<sup>th</sup> of each month to their respective DDOs with a copy to Vigilance Department without fail. The list so furnished will have to be updated under intimation to Vigilance Department by the Nodal Officer until all the Returns are acknowledged by Vigilance Department.
