NOTIFICATION

No. A.12018/62/2021-P&AR(GSW), the 29th October, 2024: In exercise of the powers conferred by the proviso to article 309 of the Constitution and section proviso to sub-section (3) of section 10 of the Mizoram Lokayukta Act, 2014 and in supersession of the Mizoram Lokayukta (Group 'D' posts) Recruitment Rules, 2017 notified in the Mizoram Gazette extraordinary issue number 421, dated 18.08.2017, except as respect things done or omitted to be done before such supersession, the Governor of Mizoram hereby makes the following rules regulating the method of recruitment to the post(s) of Group 'D' under Mizoram Lokayukta, Government of Mizoram namely:-

- 1. Short title and commencement.-
- 2. Application.-
- 3. Numbers of post, classification and level in the pay matrix or pay scale.-
- 4. Method of recruitment, age limit and other qualifications.-
- 5. Disqualification.-

- (1) These rules may be called the Mizoram Lokayukta (Group 'D' posts) Recruitment Rules, 2024.
- (2) They shall come into force from the date of their publication in the Official Gazette.

These rules shall apply to the post specified in Column I of the Schedule annexed to these rules.

The number of the said posts, classification and the level in the pay matrix or pay scale attached thereto shall be as specified in Column 2 to 4 of the said Schedule.

The method of recruitment, age limit qualifications and other matters relating to the said post shall be as specified in Column 5 to 13 of the said Schedule.

No person -

(a) who has entered into or contracted a marriage with a

person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

- 6. Training and Departmental Examination.-
- 7. Power of transfer.-
- 8. Power to relax.-
- 9. Saving .-

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other valid grounds for doing so, exempt any such person from the operation of this rule.

Every officials recruited under these rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

Notwithstanding anything contained in these rules, the State Government, in public interest, shall have the right and power to transfer any officials, so recruited under these rules to any other post or position which is equivalent in rank or grade.

Where the State Government is of the opinion that it is necessary or expedient to do so, it may, by order and for reasons to be recorded in writing, through the Department of Personnel & Administrative Reforms, relax any of the provisions of these rules with respect to any class or category of persons.

Nothing in these rules shall affect any reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Ex-servicemen and other special categories of persons in accordance with the order issued by the Government of Mizoram from time to time in this regard.
