OFFICE MEMORANDUM

Subject: Withholding of pay of Group 'A' and 'B' government servants who fail to submit their Immovable Property Returns (IPRs)-regarding

In spite of repeated instructions issued from time to time, it is observed that during the past years, some Departments/Cadre Controlling Authorities failed to withhold pay of those government servants who did not submit their Immovable Property Returns (IPRs) and whose IPRs are rejected for want of additional documents. *All Departments/Cadre Controlling Authorities are instructed once again to frequently check the status of IPRs of all Group A and B government servants under their control before processing their pay every month (till all IPRs are acknowledged) and must ensure to withhold their pay until the status of their IPRs appear as submitted/in process/acknowledged.*

It is also observed that some government servants still fail to reflect properties owned or acquired or held by him in his own name or in the name of any member of his family or in the name of any other person as stipulated under Rule 18 of CCS (Conduct) Rules, 1964. It is hereby reiterated that failure to furnish correct and reliable information can form good and sufficient reason for instituting disciplinary action against such government servants.
